

PROTOCOLS FOR REGISTRATION OF YACHTS ON LMYC REGISTER

AND

USE OF M SAIL NUMBERS

YACHT REGISTER

1. Every sailing yacht owned exclusively by an Ordinary Member(s) Sailing, on application by the owner (or owners), and after approval by the Board, may be registered in a book kept for that purpose by the Secretary to be called the Club Register. **Constitution rule 8.1**
2. Any yacht or boat which is the exclusive property of an Ordinary Member(s) Sailing may, after the approval by the Board, be placed on a list to be called the Supplementary List which among such other information as the Board considers requisite will include a description of the yacht or boat. **Constitution rule 8.2**
3. Any sailing yacht or boat on the Club Register or Supplementary List: must have its name and club clearly marked; **Constitution rule 8.3(b)**
4. Any sailing yacht or boat on the Club Register or Supplementary List: which ceases to be the exclusive property of the Member (or Members) in whose name (or names) the same appears will be removed from such Register or List; **Constitution rule 8.3(d)**
5. Any sailing yacht or boat on the Club Register or Supplementary List: which is let on hire or for valuable reward may only remain on the Club Register or Supplementary List while such letting or hiring is a valid extension of the object set out in clause 6 of this Constitution and such letting or hiring is not prohibited by any contract or association which legally binds the Club. **Constitution rule 8.3 (e)**
6. Any sailing yacht or boat on the Club Register or Supplementary List: Which in the event that a member becomes unfinancial or the boat is disposed of, the boat will be removed from the Club Register or Supplementary List (as the case may be) and the Club sail number of that boat will become vacant. **Constitution rule 8.3(f)**
7. Each Member will give the Secretary immediate notice in writing of any circumstances affecting the eligibility of his or her sailing yacht or boat to remain on the Club Register or Supplementary List. **Constitution rule 8.4**

SAIL NUMBERS

8. Any sailing yacht or boat on the Club Register or Supplementary List:
 - I. may display the Club Burgee and use the Club's boating facilities;
 - II. must only use sail numbers issued by an appropriate authority for that yacht.
 - III. Where the issuing authority is the Club the prefix "M" will be placed above the yacht's sail number in the same dimensions and proportions as the sail numbers.
 - IV. The sail numbers will be one colour on each sail and the colour of the numbers shall contrast sharply with that of the sail;
Constitution rule 8.3(c)
9. Members disposing of any yacht or boat on the Club Register or Supplementary list must withdraw Club flags and markings from such yacht or boat. **Constitution rules 8.5**
10. Sail Numbers issued by YNSW now administered by Australian Sailing are licensed to the boat and are not the property of the boat or owner. For full details of those rules refer to
