Eligibility:

Monohull Ballasted keel yachts. All yachts must hold a current Cat. 7 Safety Certificate.

Handicaps:

Arbitrary T.C.F. handicaps will be allotted to all participating yachts and used thereafter to determine a yacht's corrected finishing time.

Divisions:

There will be two Divisions:-

Divisions 1 Spinnaker & Non-spinnaker

Division 2 Spinnaker & Non-spinnaker

Note: Yachts sailing the courses may elect to race either in a Spinnaker or Non-spinnaker configuration.

This must be noted on the race entry form where provided.

Yachts will be allocated to Division 1 or 2 based upon their allotted handicap.

Starting times:

Divisions 1 & 2.

1000 hrs.

Note: Divisions 1 and 2 will start together and sail the same course.

Entries:

Eligible yachts may enter by completing the attached Entry Form and lodging it with the RMYCT office or e-mailing to sailing@rmytoronto.com.au.

Entries close Wednesday 14th November 2018

Late entries will be accepted up to 1700hrs Friday 16th November 2018

Late entries will attract an additional fee of \$15 payable at the time of entry.

Entry Fee:

\$30.00. (Including GST). RMYC pointscore competitors \$15 for point score entry only or \$30 for point score and 30 Miler entry.

Presentation:

A free BBQ will be provided after the race with the presentation of prizes commencing as soon as practical after the last yacht finishes.

Sailing Instructions:

Sailing Instructions will be available at the R.M.Y.C.T. office from the 5th of November 2018 and will also be posted on the R.M.Y.C. website at rmytoronto.com.au.

DECLARATION BY PERSON IN CHARGE:

I declare that all the above details are correct & that the vessel entered holds a current Category 7. (or above) safety certificate. I agree to be bound by the 2017-2020 Racing Rules of Sailing (R.R.S.) of the International Sailing Federation (I.S.A.F.), as amended, the prescriptions and special regulations of Australia Sailing, the 'Notice of Race', (except as altered by the Sailing Instructions), by the Sailing Instructions and by all other rules that govern the event.

I acknowledge that RMYCT is not responsible for the seaworthiness of a boat whose entry is accepted or the sufficiency or adequacy of its equipment. Furthermore I agree to indemnify RMYCT from any responsibility in regard to myself, my crew and my vessel during this event. I agree that this indemnity extends to all Officers, Sponsors and Agents of RMYCT

I understand my obligation under RRS Fundamental Rule 4, which states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone". I agree that RMYCT, their employees and volunteers may exchange information about me that includes the information I provide to administer my entry into the event and to run their business. I agree that the name of the boat and her crew nominated in my entry and my results may be used by RMYCT to publicise and promote activities at RMYCT and may be released to the press for public audience. I agree that all information may be disclosed to necessary stakeholders in emergent situations and when bound by law to do so.

The person who signs and lodges this entry form with RMYCT declares that the vessel entered is currently covered by adequate Third Party Property Liability Insurance and Third Party Personal Liability Insurance cover of not less than \$10,000,000 for any one incident & that this insurance covers them for the type of racing they will be participating in. This includes competing in races for which spinnakers are allowed even though the person may not be using a spinnaker on their vessel.
