1.0 RULES

- 1.1 The races will be governed by the Racing Rules of Sailing (RRS) of World Sailing and the Prescriptions and Special Regulations of Australian Sailing (AS).
- 1.2 Appendix T will apply

2.0 ADVERTISING

- 2.1 Advertising is unrestricted as permitted by World Sailing Regulation 20.

3.0 ELIGIBILITY

- 3.1 Entry is open to ballasted mono-hulled and multihull yachts, with a minimum crew of 2, and which shall have a current Equipment Audit Form for Category 7 or above.
- 3.2 A yacht shall have current Third Party Insurance for not less than \$10 million.
- 3.3 A Yacht shall be familiar with their participating Club's Covid-19 Safety plan and has submitted an appropriate Skipper Declaration.
- 3.4 The event is open to yachts using spinnakers and non-spinnaker yachts.

4.0 ENTRY

- 4.1 An Entry shall be lodged through the participating Club's Entry Systems and the yacht shall nominate on the entry form if the Yacht intends not to use a spinnaker. The nomination shall not be changed during the series.
- 4.2 The race entry fees shall be paid through the participating Club's entry system for the amount specified by each club. Casual entries close at 1700 on Thursday before each race. Series entries close at 2400 hours Monday 14th September 2020.
- 4.3 Series entrants for the 2020-21 LMYC, RMYC and WASC Saturday Pointscore series are automatic entrants for this series at no cost.
- 4.4 Casual entries will be given a result for the day, but their scores will not contribute to the RKR shield results.
- 4.5 Each Club will be responsible for the verification of a respective Yacht's entry, handicap, and their compliance with section 3.0. RMYC and WASC indemnify LMYC and its officers for any failure by RMYC or WASC to adhere to this rule.

5.0 SCHEDULE OF RACES

- 5.1 Saturday 19th September 2020: Race 1
Warning signal for Division 1 is scheduled for 1315 hours.
- 5.2 Saturday 10th October 2019: Race 2
Warning signal for Division 1 is scheduled for 1315 hours.
- 5.3 Saturday 28th November 2019: Race 3
Warning signal for Division 1 is scheduled for 1315 hours.
- 5.4 Saturday 16th January 2020: Race 4
Warning signal for Division 1 is scheduled for 1315 hours.
- 5.5 Saturday 27th February 2020: Race 5
Warning signal for Division 1 is scheduled for 1315 hours.
- 5.6 Saturday 13th March 2020: Race 6
Warning signal for Division 1 is scheduled for 1315 hours.

NOTE: The Races in the Regatta will be run conjointly with the LMYC, RMYC and WASC Summer Pointscores.

6.0 COMMUNICATIONS

- 6.1 Signals made ashore will be displayed from the Race Committee Box on the SW end of LMYC marina and the Race Committee Box on North East end of RMYC marina and the Flag mast on shore in front of WASC clubhouse.
- 6.2 The official notice boards will be LMYC Racing office. RMYC noticeboard and WASC noticeboard.
- 6.3 A boat retiring before, during or after a race shall notify the RC of its intention to do so by calling the RC r on mobile 0414 450 022 or VHF (Channel 71) at the earliest possible opportunity, failure to do so will result in a boat being scored equal to the last boat to complete the course in the RKR shield +1, and DNC in divisional results.

7.0 DIVISIONS AND SPINNAKERS

- 7.1 There will be three divisions, with competitors placed in each division at the discretion of the RKR Sailing Committee.
- 7.2 All races and divisions will be mixed spinnaker and non-spinnaker.
- 7.3 All boats will display a pennant on their backstay showing which division they are racing in (White, Green, and Blue) to assist the Race Officers in distinguishing boats finishing at the common finish

8.0 SCORING AND RESULTS

- 8.1 Scoring will be in accordance with RRS Appendix A.9
- 8.2 The Race Committee will assign a TCF handicap to each boat based on previous RKR performance, or by the RKR handicap committee if no performance history is available.
- 8.3 A boat's result will be its elapsed time x TCF to determine its corrected time in each race. The boat with the lowest corrected time shall be scored first, subject to penalties, retirement or redress, if any, the second lowest, second, and so on.

9.0 DISCLAIMER

- 9.1 Each competitor participates in the R A Mackay Yacht Brokers and Whitworth Marine and Leisure R K Robertson series, entirely at their own risk and subject to the RMS Risk Warning.
LMYC, RMYC, and WASC will not accept any liability for material damage or personal injury or death sustained in conjunction with, prior to or after the Regatta.
